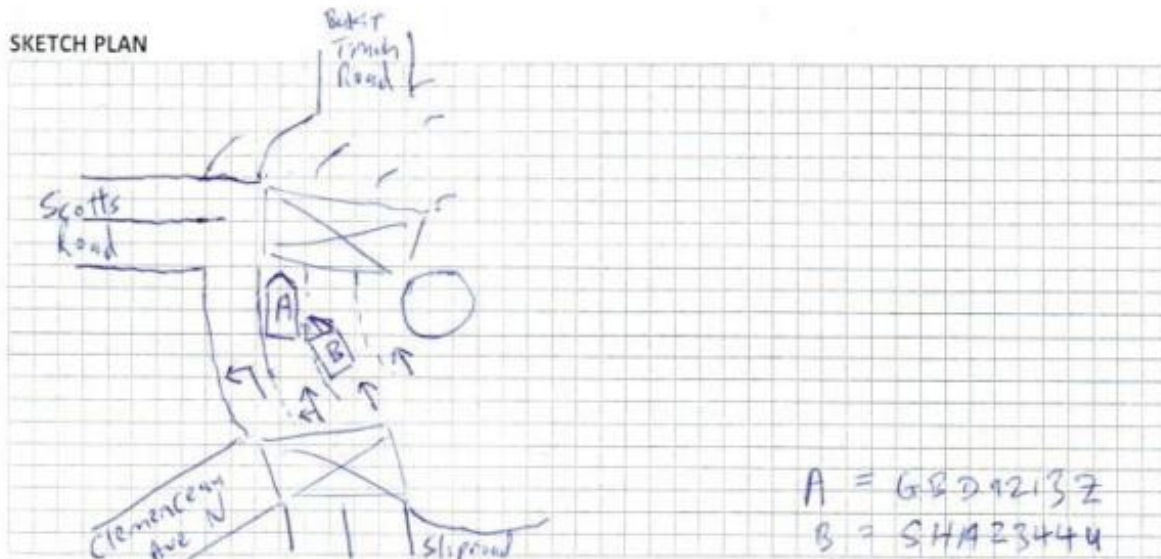

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 27 MAY 2020 at around 1745 hrs, I was driving my Nissan NV200 [G8D9213Z] on the 3rd outermost lane of the roundabout at the Newton Circus roundabout. I had exited from the sliproad's inner lane to join the roundabout and stayed ~~on~~ throughout the 3rd outermost lane of the roundabout. I had intended to go through towards Bukit Timah Road. As I approached the junction of Scotts Road, a comfort Toyota Taxi [SHA2344U] hit my right rear of my van because he had wanted to turn left to Scotts Road. My lane is a turn left / go straight lane. My Van is already near the junction. His lane is a go straight only lane.

I had not switched on my signal lights as I am going straight. My right rear had a long ~~scratch~~ scratch and a long dent with chip off. His Taxi left bumper had some scratch.

After the accident happened, we shift our vehicles to the side of Scotts Road.
