
Our insured stated that he was travelling straight all the time in his GIA report.

However we enclose our driver statement report for your investigation. Our taxi was stationary position, your client lorry swerved from the left and hit onto our taxi left side mirror.


After the accident, your client did not stop his lorry and continues going straight.
