Dear Sir/Mdm,

On 28 May 2020 me and my wife was making our way back from Jurong West after making a delivery. We took PIE to Changi and exited Lornie Road. As we were making our way to our home at Bishan St 23, we took the Lornie towards Upper Thompson flyover. It Started to pour heavily the moment we entered this route. As I was observing the speed limit I gradually decrease my vehicle speed accordingly to the road speed limit and when we were making the turn along the flyover I brake harder as the rain was heavy. Little do I know my front wheels got locked up and my vehicle skidded spinning 180/360 degrees making it hard to maneuver and it knocked against the wall. (From middle lane to 1st lane)

We were immediately assisted by by-passers whom stopped their vehicle to render assistance to us. They called for an ambulance immediately after assisting to us as my wife took a knock at the B pillar during the impact and has cause a bruise to her left eye as her chair was decline in a lying position as she was sleeping.

As a driver I had no injury but was in a state of shock.

After alighting for the vehicle I immediately checked on my wife and our surroundings to see if I have damaged any property or third party. Thankfully there were none.

When the ambulance came they attended to us with immediate medical response and followed the

procedures and measures. Whilst my wife was escorted to the hospital I stayed back to wait for TP and the tow truck. After the TP onsite assistance, I left immediately for the hospital to see my wife and to accompany. (SGH hospital).

Thankfully/insyaallah my wife got a minor bruise to her left cheeks and the doctor prescribe her with painkillers.

We left the hospital at about close to 1am to head home.

A follow up action at my end will be required the next morning at my insurer workshop for claims on repair works to ensure that my vehicle would be restored adequately and deem safe for driving in our Singapore Roads.
