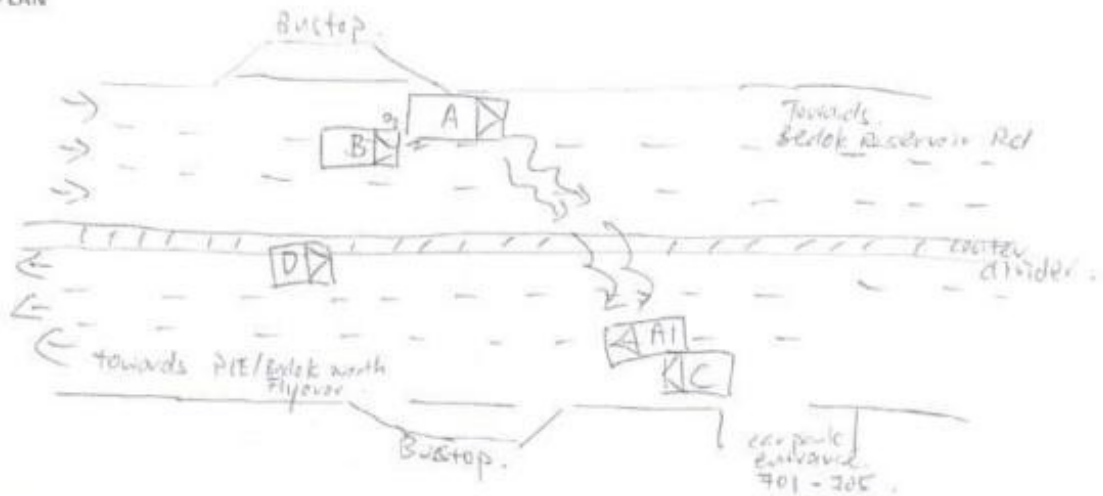

The impact centred to push my vehicle against the kerb and caused my vehicle to steer towards the center divider and what to the opposite side of the road. I was in a daze and lost consciousness. All I know after the accident is that I was involved in an accident of 4-car accident. I did not know how I hit onto vehicle C or D in which order.

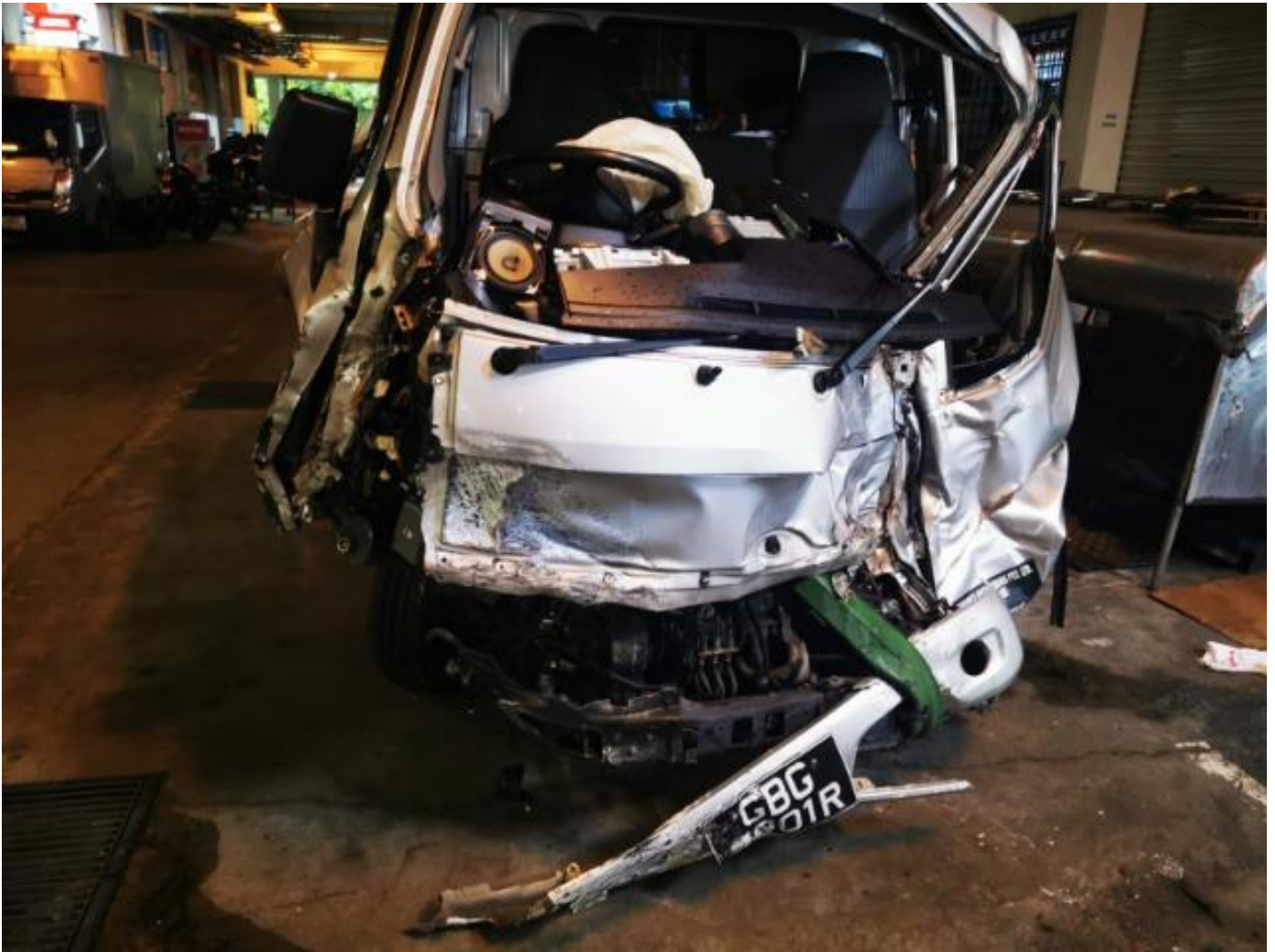

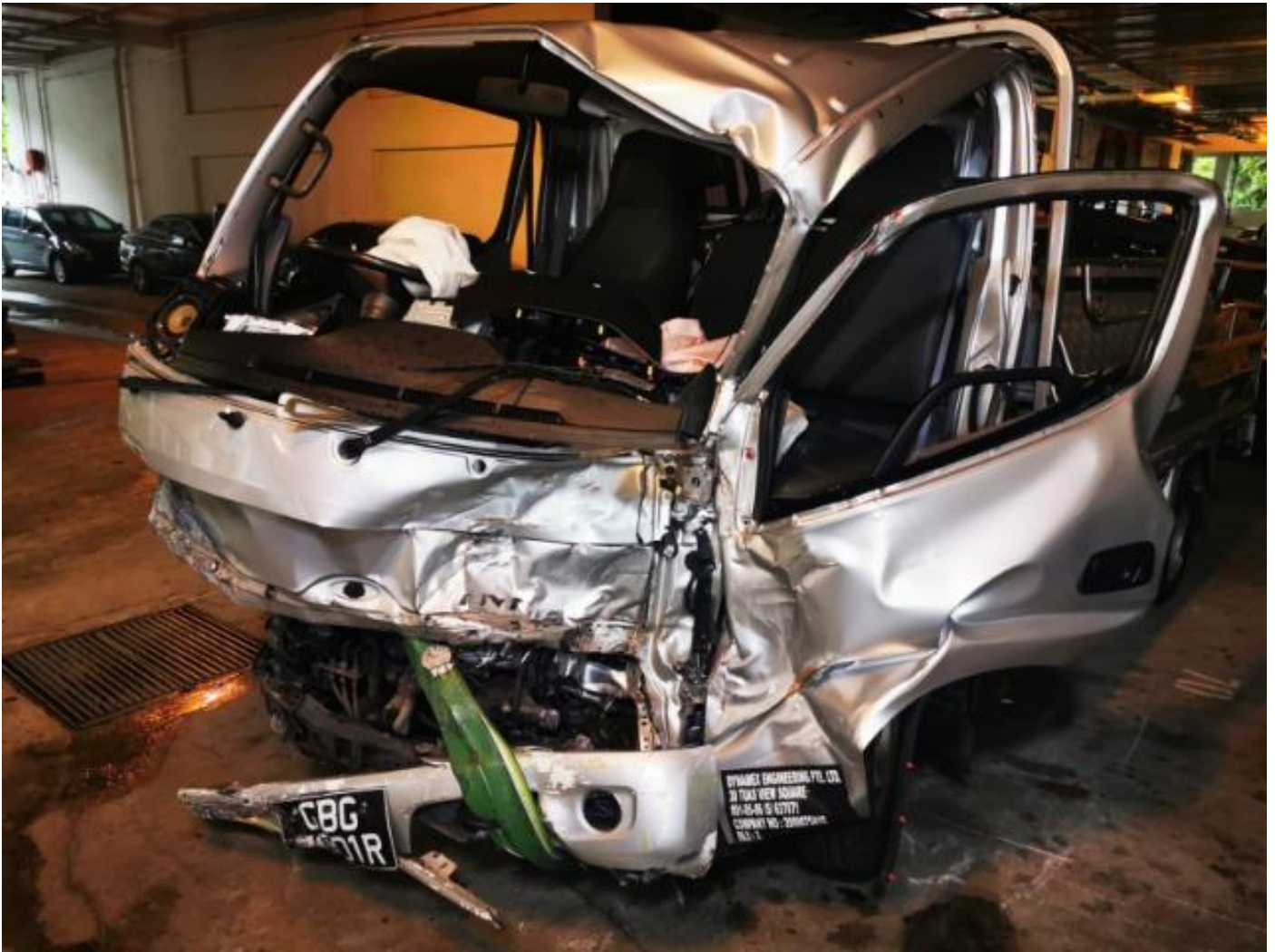
