Circumstances of Accident

ON MONDAY, 8 MAY 2020 AT APPROXIMATELY 10.15 AM, I WAS DRIVING ALONG LOWER DELTA ROAD TOWARDS SENTOSA, WHEN I STOPPED BEHIND ANOTHER VEHICLE (REG VEHICLE NO. SMG 2258 U) (THE OFFENDING VEHICLE) AT A SET OF TRAFFIC LIGHTS WHILE THE LIGHT WAS RED. SHORTLY THEREAFTER, THE LIGHT TURNED GREEN AND ALL OF THE TRAFFIC GOING IN THAT DIRECTION PROCEEDED FORWARDS IN THE NORMAL FASHION, INCLUDING THE OFFENDING VEHICLE. BUT FOR NO APPARENT REASON WHATSOEVER, THE OFFENDING VEHICLE SLAMMED ON ITS BRAKES AND CAME TO A COMPLETE STOP IN THE MIDDLE OF THAT INTERSECTION TOTALLY UNEXPECTEDLY AND WITHOUT WARNING. THERE WAS NO REASON FOR OR NEED TO STOP AND NO OTHER VEHICLES WERE BLOCKING OR ABOUT TO BLOCK OR MOVE INTO HIS LANE AHEAD OF HIM. I BRAKED BUT NOT IN SUFFICIENT TIME TO AVOID A MINOR COLLISION WITH THE REAR OF THE OFFENDING VEHICLE. I ASKED THE DRIVER OF THE OFFENDING VEHICLE WHY HE HAD SLAMMED ON HIS BRAKES LIKE THAT AND HE WAS UNABLE TO PROVIDE ANY ANSWER. HE SAID HE WAS DELIVERING FOOD. AFTER THE ACCIDENT HE TURNED RIGHT AT THAT INTERSECTION SO IT IS CLEAR TO ME THAT HE STOPPED BECAUSE HE REALISED HE WAS IN THE WRONG LANE. NO OTHER VEHICLES OR PASSENGERS WERE INVOLVED IN EITHER CAR. NO WITNESSES.

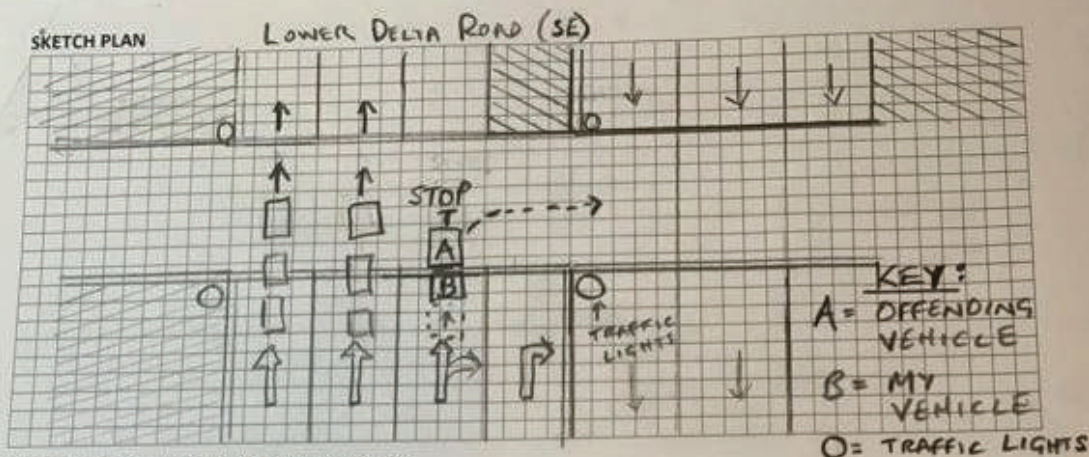

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On Monday, 8 May 2020 at approximately 10:15am, I was driving along Lower Delta Road towards Sentosa, when I stopped behind another vehicle (reg./vehicle no. SM922584) (the "Offending Vehicle") at a set of traffic lights while the light was red. Shortly thereafter, the light turned green and all of the traffic going in that direction proceeded forwards in the normal fashion, including the Offending Vehicle. But, for no apparent reason whatsoever, the Offending Vehicle slammed on its brakes and came to a complete stop in the middle of that intersection totally unexpectedly and without warning. There was no reason for or need to stop and no other vehicles were blocking or about to block or move into his lane ahead of him. I braked but not in sufficient time to avoid a minor collision with the rear of the Offending Vehicle. I asked the driver of the Offending Vehicle why he had slammed on his brakes like that and he was unable to provide any answer. He said he was delivering food. After the accident he turned right at that intersection - so it is clear to me that he stopped because he realised he was in the wrong lane. No other

vehicles or passengers were involved in either car. No witnesses.
