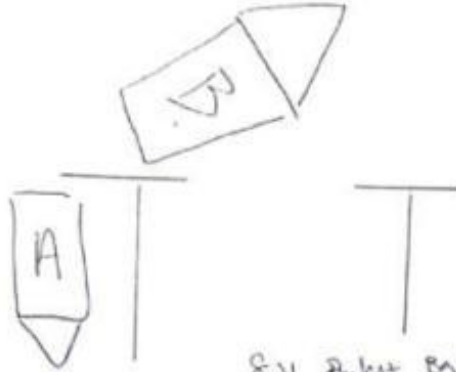


# Sketch Plan #2

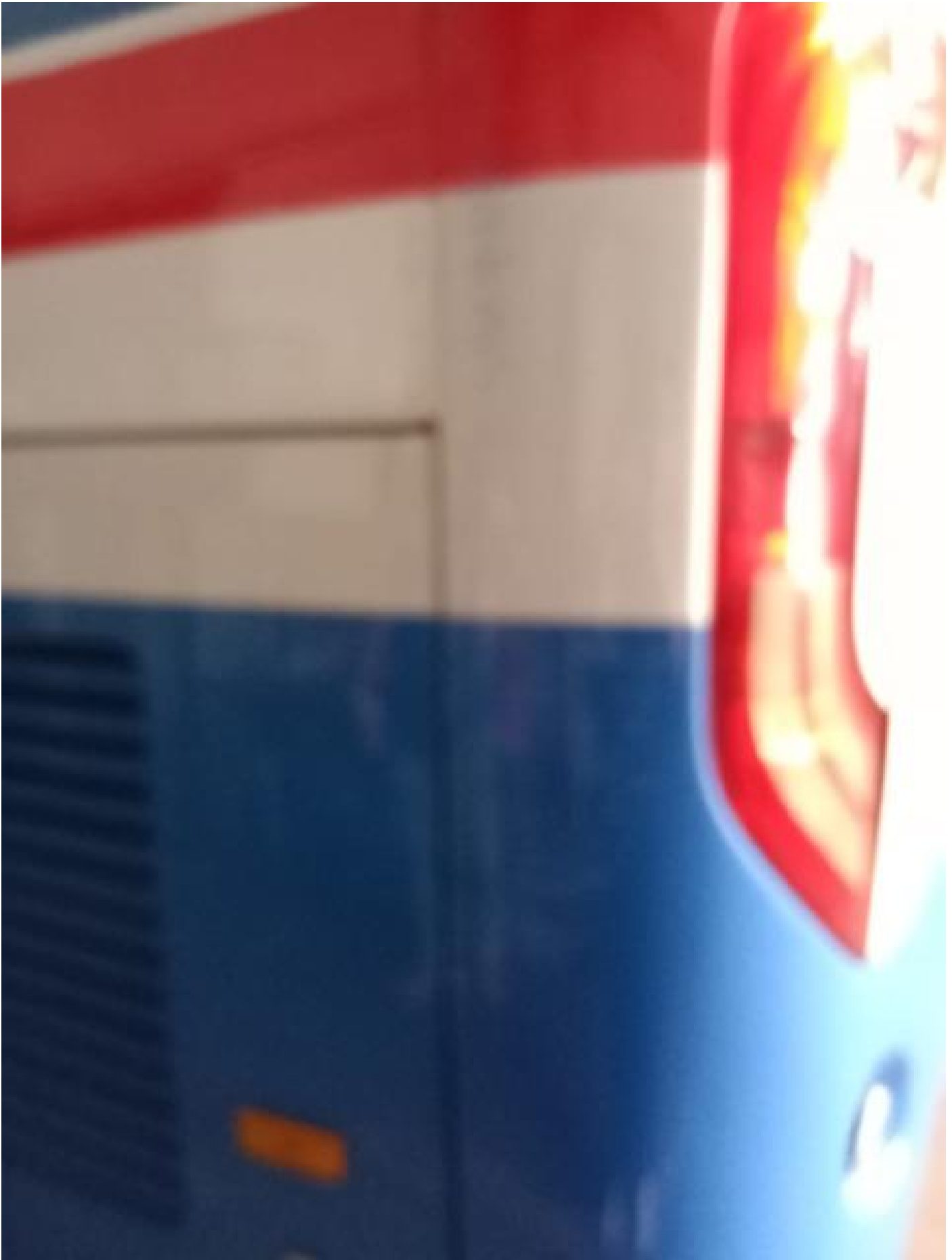
