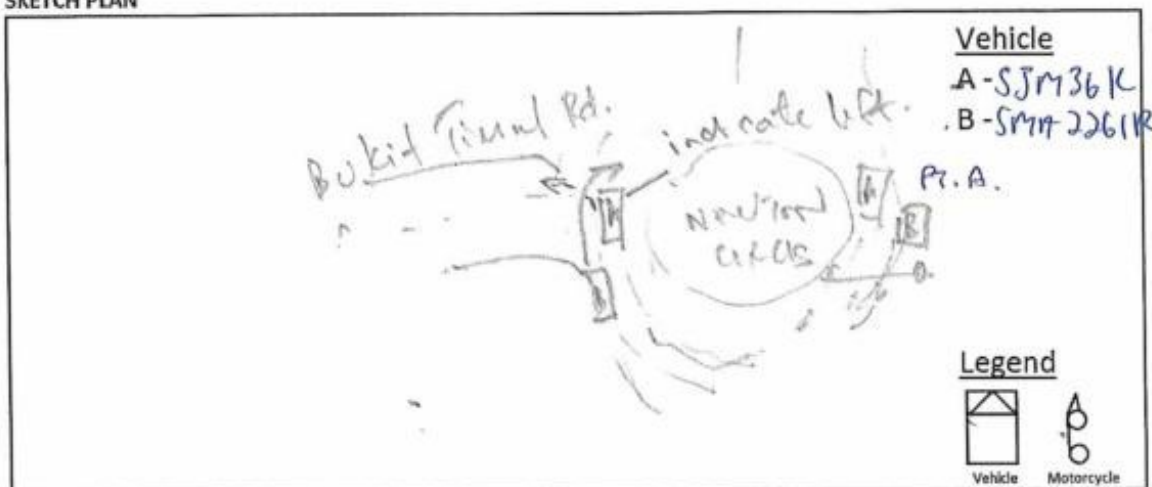

BUKIT TIMAH ROAD TOWARDS SUNSET RD.

AFTER PT. A TOGGLE junction, CAR B SWA 2261R
on my left moved off behind me.

CAR C was on my left, I wanted to turn
left onto Bukit Timah Rd and indicated as such.

I was moving slowly in my lane as CAR
SWA 2261R travelled quickly and overtook me
very close to and cut in front of me. His car
scrapped my car's left front bottom bumper
and wheel. He suffered scratches to his right
door. No major damage or injuries.

He cut into me & accused me of moving
left as I indicated but still in my lane as
seen on the camera - front & back.



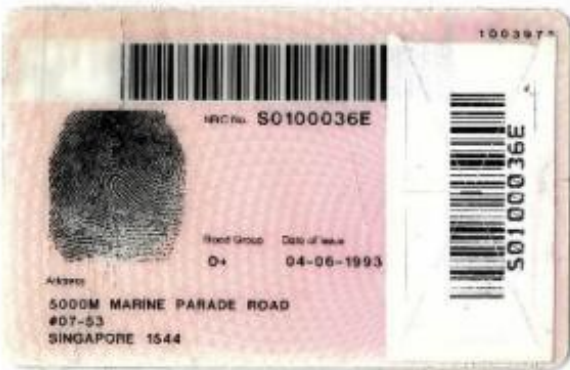

 - (iii) carrying out and/or dealing with my instructions or responding to any enquiries by me;
 - (iv) administering my claims (including the mailing of correspondence, statements, invoices, reports or notices to me, which could involve disclosure of certain personal data about me to bring about delivery of the same as well as on the external cover of envelopes/mail packages); and/or
 - (v) complying with applicable law in administering, processing, handling and/or dealing with my claims.(collectively the "Purposes")
