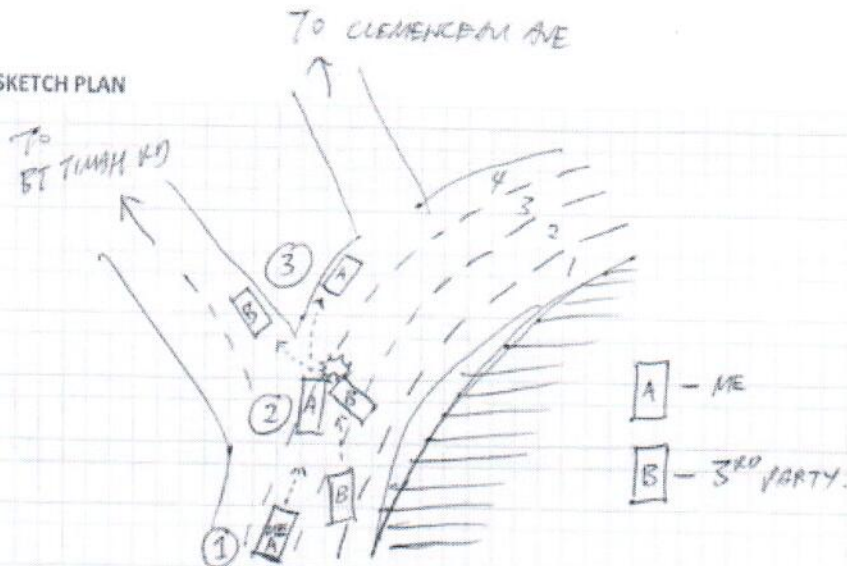

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

- ① I was proceeding on lane 3 (2nd lane on left) with intention to filter to lane 4 (leftmost lane) to turn to Clemencean Ave N.
- ② Observed 3rd party filtering from lane 2 to lane 3 and exiting lane 2 even though I was approaching. I veered towards lane 4 to avoid 3rd party vehicle but was unable to avoid the collision as the 3rd party vehicle did not stop at lane 3 and instead proceeded to exit lane 3 towards lane 4.
- ③ After the collision, I proceed forward along lane 4 and stopped to check. 3rd party vehicle proceeded to exit lane 4 and stopped at slip road leading towards Bukit Timah Road.
