

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a claim from Triple-T Automobile acting on behalf of the owner of SLH2383Y against your motor insurance policy.

Based on the accident report and accident scenario, liability is not in your driver's favour as your driver was turning out from minor road and collided with third party who was on main driveway. We will therefore proceed to negotiate for an amicable settlement with the Third Party.
