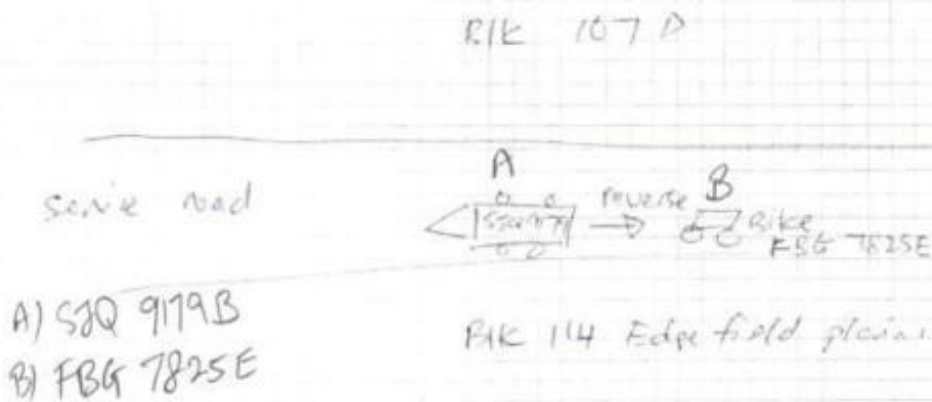

The bike was parked stationary along the service road between RIK 114 Edgefield plains & RIK 107D. I started reversing my car, SJQ 9179B after checking my rear mirror and side mirrors. Nothing was on my mirror. I stopped immediately after hearing a bang sound. I switched off my engine and check my rear of my vehicle. Then noticed that a bike had been toppled.

The rider was not at the scene and I waited for around 5 min before he appeared. and we lifted his bike. There was no injury as the rider (Mohd Daniel Bin Adallah T00225532) was not present when the accident happened.
