





Vocational Licence

Notice

The Multi-Ministry Taskforce announced on 19 May 2020 that it will allow activities to resume safely in a controlled approach over three phases from 2 June 2020, starting with economic activities that do not post a high risk of transmission.

In line with the objective of safe distancing and keeping the safety and health of the public and all public officers as our utmost priority, vocational licence counter services at LTA's Customer Service Centre and e-lobbies at Sin Ming Drive will remain closed in Phase 1 ("Safe Re-opening"), which will be implemented from 2 Jun 2020.

During this period, LTA's vocational licence services will remain accessible to the public via the GoBusiness Licensing Portal, OneMotoring and AXS. To support vocational licence holders and applicants to abide by the safe management measures, LTA will make the following adjustments durthis period:

VL Holders are given a 6-month extension from the date of VL expiry to submit the Vocational Licence medical form. LTA will also reach out to affected VL holders via SMS.

*VL Holders will receive the renewal notice 1-month prior to your VL expiry.

Understanding Vocational Licence	A vocational licence allows you to drive a taxi, private hire car or bus, or work as a bus attendant on a school bus in Singapore.
	There are different types of vocational licences, each with its own requirements and application process.
	Each vocational licence is valid for 3 years and is subject to age restrictions.

	1. Taxi Driver's Vocational Licence (TDVL)
	2. Private Hire Car Driver's Vocational Licence (PDVL)

Understanding vocational licence

To drive a taxi, private hire car or bus, or to work as a school bus attendant, you must have a vocational licence. Different vocational licences have different requirements

The application process will take about 10 to 15 working days, if all the documents are in order.

Validity period for a vocational licence

Once your vocational licence is issued, it is valid for 3 years, depending on your age. If you are 68 years and above, the validity period of your vocational licence may be shorter. The statutory age limit for a vocational licence is 75 years old.



Your vocational licence will be revoked if you are convicted in court, or if your driving licence has been disqualified or suspended for one year or more.

Renewing your vocational licence

A month before the licence expires, you will receive a renewal notice from LTA to renew your vocational licence. To renew your licence, you must meet the requirements stated in your renewal notice. If you have misplaced your renewal notice or did not receive it, contact us.

You can renew your vocational licence and make payment via the modes below:

Q: Where can I renew my Vocational Licence (VL)?

A: You may refer to your renewal notice for instructions to renew the vocational licence (VL) <u>before</u> <u>the VL expiry date</u>. If you are a registered taxi driver, you can renew your VL at your taxi company.



Late renewal of vocational licence

If your licence has expired within 6 months from the expiry date, you may email us at feedback@lta.gov.sg. We will advise you on the steps and the requirements that you will need to ful before your licence may be renewed at a fee of \$40. There is no late renewal fee payable.

You must pay an administrative fee of \$25 if you renew more than 6 months after the expiry date.

If your vocational licence has expired for more than 3 years, you must submit a fresh new application

To renew your expired vocational licence which has expired for more than 3 years, follow these steps:

Step 1: Submit your application for late renewal

If your licence has expired for more than 6 months from the expiry date, you may apply for late renewal. You may email us at feedback@lta.gov.sg. Please note that you are required to pass LTA's screening criteria before your application can be approved.

Please attach the relevant documents below in your email to us.

Required documents:

- Completed late renewal application form
- Invoice of \$25 late renewal fee paid via One Pay Hub (Select "Application Fee for Late Renewal of Vocational Licence")









You may be required to meet additional requirements, such as going for a medical examination or refresher course, before your renewal application can be completed.

Step 3: Make payment

When your application to renew is approved, you will need to pay a non-refundable licence fee of \$40 using credit/debit card via One Pay Hub (Select "Vocational Licence Renewal Fee For Other Drivers (Non-Refundable)")
