Brief Details.

On the 28/02/2020 at about 2140hrs, I was coming out from Parc Riviera condominium to west coast vale road. A lorry driver (GY5032K) made an illegal U-turn and I could not stopped in time and my motorcycle (FBB6098U) front smashed against the lorry left side.

As a result of the accident, my motorcycle front is seriously damaged while the lorry I am unsure if it sustain any damage at all. The particulars of the lorry driver is namely Pethaperumal Yoganathan (G2327946R). Subsequently, the ambulance came and I was then conveyed to NUH for further checks.

The traffic police also were at the scene and I was given a case card however I am unsure where I placed it. I received a total of 6 days medical leave from 28/02/2020 to 04/03/2020 for my injuries. I sustained abrasion on my left elbow, stomach area and right knee. My motorcycle do not have any camera installed.
