Brief Details.

On 14 January 2019 at about 1100hrs, I was driving my vehicle bearing registration plate number JQB737 along Bukit timah expressway. The road was dry and the traffic was slightly heavy. I was driving at the most left lane alone. Subsequently, before the exit of Woodlands Avenue 12, I was driving slowly. Out of a sudden, I heard a loud braking sound. It was followed by a chain collision involving 4 vehicles including mine. When I was hit by a van behind me, my vehicle pushed forward colliding onto the van in front of me.

As such, I alighted from my vehicle to make a check. Here are the vehicles involved:

- V1- GW5853T (Lorry)
- V2- GBG1695C (Van)
- V3- JQB737 (Car)
- V4- GBH8691L (Van)

Apparently, earlier while I was moving slowly according to the traffic, V1 had collided onto V2 first and within split seconds V2 hit my vehicle. Subsequently, my vehicle moved forward colliding onto V4. All the drivers involved does not seem to have any injuries on them. Due to the accident, our vehicles sustained the following damages:

- V1: Front bumper badly dented
- V2: The rear portion of vehicle badly damaged, Front portion of vehicle slightly damaged (dents)
- V3: The rear portion badly damaged, Front portion slight dents and scratches, Side bumper misaligned
- V4: Slight dents on rear portion with paint marks

Due to the impact of the accident, I feel giddy. As such, I went to the clinic at Eastern Medical Centre and was given 2 days of MC. There was no traffic police or ambulance who came to scene. I got an in car camera. However, I am not sure whether it was recording or not. That's all.
