Brief Details.

The accident happened at the traffic lights of the junction of Serangoon Road and Moonstone Lane (in the direction of Upper Serangoon). I was in the right most lane. Another accident had just happened immediately in front of me. As the lights changed to green, I signaled to filter left so as to go around the two stationery vehicles ahead of me. I started filtering left when I saw a gap open up as the vehicle in that lane (SHA9725H, a taxi driven by Santhiramocan s/o N Sinnayah) appeared to either be giving way or was slow to move off at the traffic lights. Unexpectedly, the taxi then drove into the side of my car. Based on observation, both vehicles only sustained minor damage to the bodywork. I understand that Santhiramocan has alleged that he was injured in the accident which is the reason that I am making this report. I have some photographs of the accident and the damage on both vehicles if required.
