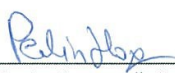
8. Consent under the Personal Data Protection Act (PDPA)

 - (ii) for complying with requirements under any regulations, laws or court orders.

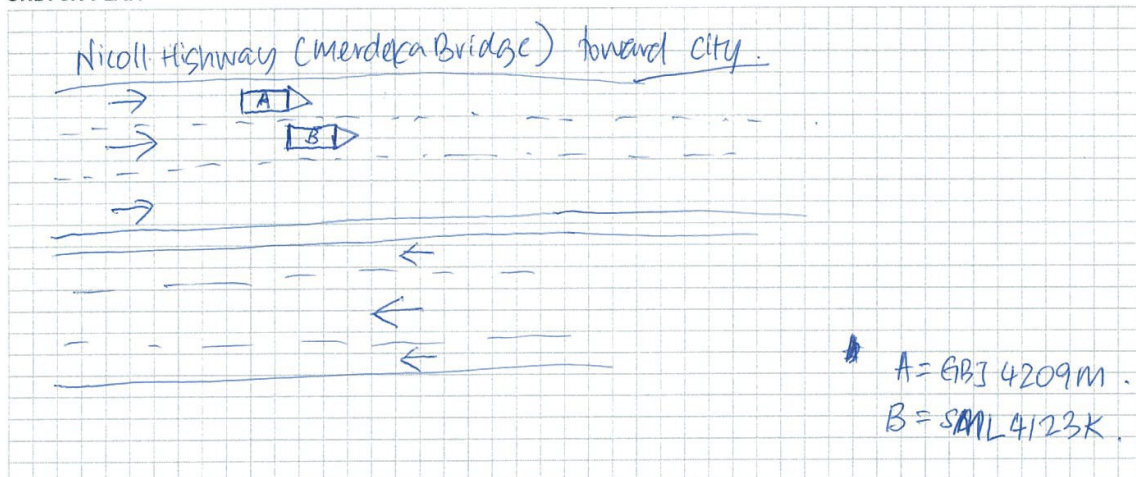
