

As the AYE was busy, we ~~left~~ drove off asap. I had a Grab Rider with me. Whether was fine.

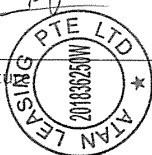

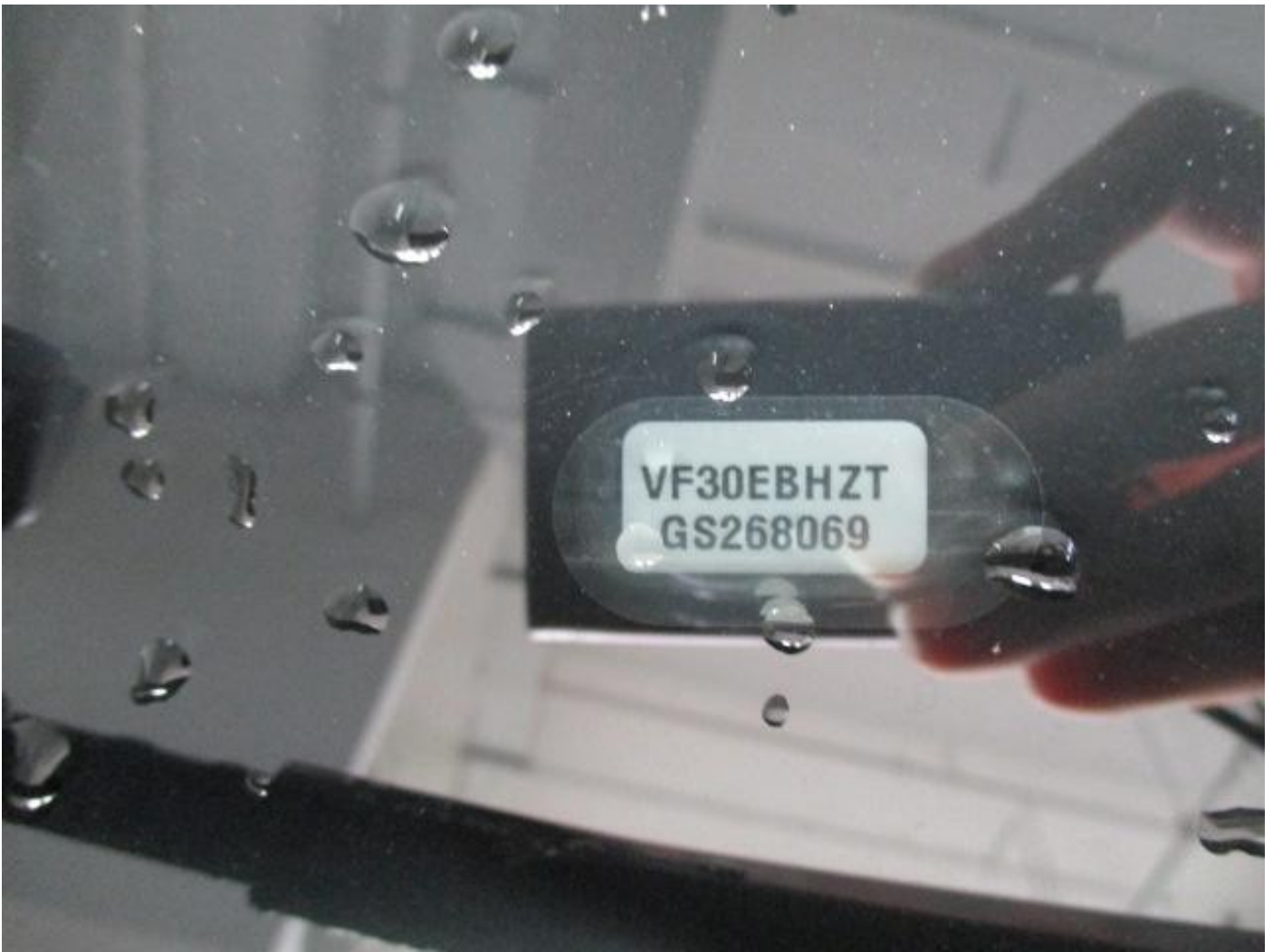
