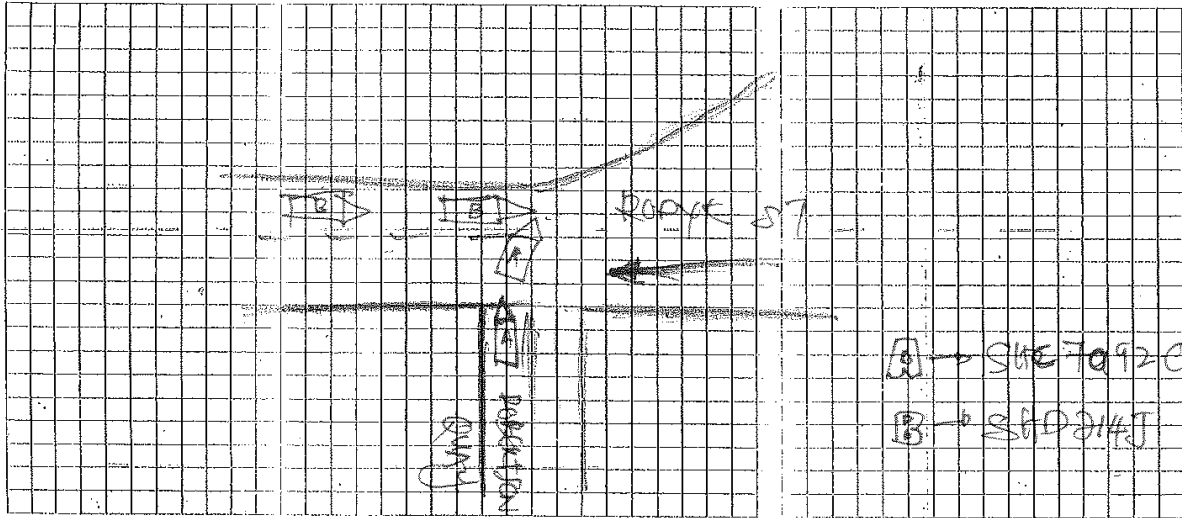

 - (iii) carrying out and/or dealing with my instructions or responding to any enquiries by me;
