 - (II) For complying with requirements under my regulations, laws or court orders.



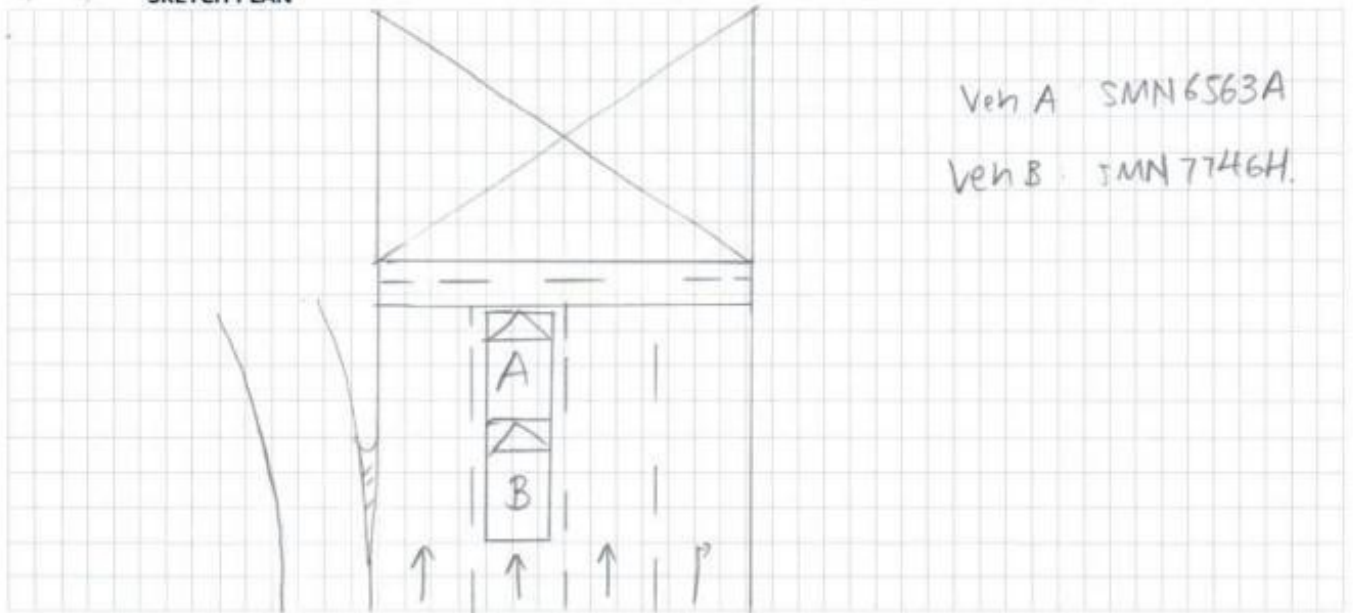
