**Brief Details.**

On 02/07/2020 at about 2300hrs, I was driving along KPE highway and I was exiting 9A to Tampines Road. I then stop at the exit 9A to look for on coming traffic along Tampines road. Suddenly, a vehicle (SLJ 7174R) come from the rear and collided on the rear right portion of my vehicle. The rear right portion of my vehicle was damaged. After the accident, due to the impact, I felt pain on my neck and when to seek treatment. I was given 7 days medical leaves. I am lodging this report for medical claim purposes.

At that point of time, I was fetching 2 customers namely Dino S/O Balasundra (Hp: 81898026) and Denise Tan Li Lin (Hp:97720171). Both have injury after the accident and they have also seek medical treatment and given 7 days medical leaves.
