**RE: TRAFFIC OFFENCE APPEAL AGAINST ALLEGED OFFENCE FOR NON – INJURY  
TRAFFIC ACCIDENT WHICH OCCURRED AT OPEN CARPARK AT BLK.134,  
BEDOK RESERVOIR ROAD ON 3<sup>RD</sup>.JULY 2020 AT APROX. 0845 HRS.INVOLVING  
VEHICLES GBH 7720 T AND SML 2665 B.**

I wish to appeal the alleged offence against me for “Careless Driving & Causing Hurt” which I did not commit. I am requesting you to recede the above mentioned charge offence as I am truly and factually innocent. I am a careful driver and had a cleaned driving record for 48 years.

I am a loyal and faithful Civil Servant with the Housing Authority and PAP’s ward Town Councils all my life. I hold good Principles, Ethics, Virtues and maintain a good Values in Life.

I am a resident here for the past 20 – 25 years. This is my Homeground and HomeTown. I knew most of my Neighborhood residents and Car Owners. We are Nice, Warm, Gracious and Caring Neighbourly Residents here and we care and nurture to each other’s needs.

On the 3<sup>rd</sup>.July 2020 at approximately 0845 hrs., I was about to set off for work. Being a careful and cautious driver, I precisely instructed my man, Mr. Kannaiyan Senthil, to station at the carpark driveway to keep a lookout for any on – coming vehicle to slow down and come to a dead stop to allow me to reverse safely. When the Carpark driveway was cleared to my favor. I switched on the reverse “Blinker Lights” and engaged the reverse gear with a loud reversing “Beeping” warning signals. Just as I slowly reversed out of the carpark lot no:39 barely 300 mm (one foot) , I was shocked to hear a swift impact hitting on the rear of my vehicle. I immediately stepped on the brake pedal. I realized a car SML 2665 B, driving speedily, recklessly and irresponsibly into an enclosed - end small HDB carpark smashing his car’s side against my tail – board of my lorry.

Just then my man’s instant response was to shout out and proclaimed to me that he, Kannaiyan Senthil had directed, signaled and marshaled the on coming speeding car, SML 2665 B, who drove rashly, impulsively, totally ignored and disregard his hand signals to slow down his car.

The said driver Mr.Teo Thiam Soon break – off about 10 metres away upon collision. He examined his owned side damages and immediately walked towards my lorry and asked me how to resolve the matter. I repudiated his reckless, thoughtless, senseless and uncaring driving behavior. I told him this is small “Dead – End” HDB carpark, Mr. Teo TS should had slow down and reduced his speed when my man distinctively gave cleared signals to him prominently to come to a freezed.
