May I seek your assistance to perform a detailed mechanical inspection of the <u>4 vehicles</u> below on an <u>urgent basis</u>.

### a) Case IAFP-IB-20200630 - Mechanical Inspection of Motor Lorry, PMV2774 (TP/IP/27171/2020)

On 25 June 2020 at about 4.15am, the lorry was travelling along the 2 lanes slip road from KJE into BKE(Woodlands). The slip road is a left road bend. While travelling along the slip road, the driver claimed the lorry brakes malfunction and hence he could not apply brake. As a result, he lost control of his lorry and collided onto the right wall. Due to the collision, the lorry overturned to its right side and blocked the 2 lanes of the slip road. The slip road was closed for hours due to the accident.

c) <u>Case IAFP-IB-20200630 - Mechanical Inspection of Motorcycle, FBN7084P (TP/IP/16737/2020)</u>

On the 27 March 2020 (Friday) sometime around 7.20 a.m., the driver was travelling straight along PIE (AP) on right of 4 lanes while a motorcycle, FBN7084P was riding between the right lane and lane 2 of 4 lanes. When the rider was riding between the said motor car and witness's vehicle, the right portion of the said motorcycle collided onto the left portion of the said motor car. The impact caused the rider to lose control and fall in front of the said motor car and the said motorcycle's left front and rear tyres ran over the said motor car.

## d) Case IAFP-IB-20200630 - Mechanical Inspection of Power-Assisted Bicycle (TP/IP/00693/2020)

On 5 January 2020 (Sunday) at about 5.52 a.m., the 1<sup>st</sup> Accused, who was alone in his motor car, was travelling straight along Cantonment Road towards the direction of Keppel Road (against the traffic flow) on an unknown lane of the 3-lanes road. At this juncture, the Deceased was cycling on her power-assisted bicycle, along Cantonment Road towards the direction of Outram Road, on lane 3 of the 3-lanes road and was making a right turn from an opening along the centre divider into a carpark entrance of "The Pinnacle@Duxton". While in the midst of making the right turn, the 1<sup>st</sup> Accused drove against the flow of traffic from the Deceased's right to left side and the front portion of the 1<sup>st</sup> Accused's motor car collided into the Deceased's right side. Due to the impact, the Deceased was flung upwards and was thrown onto lane 3. While the Deceased was still lying on the road, the 2<sup>nd</sup> Accused ran over the deceased.
