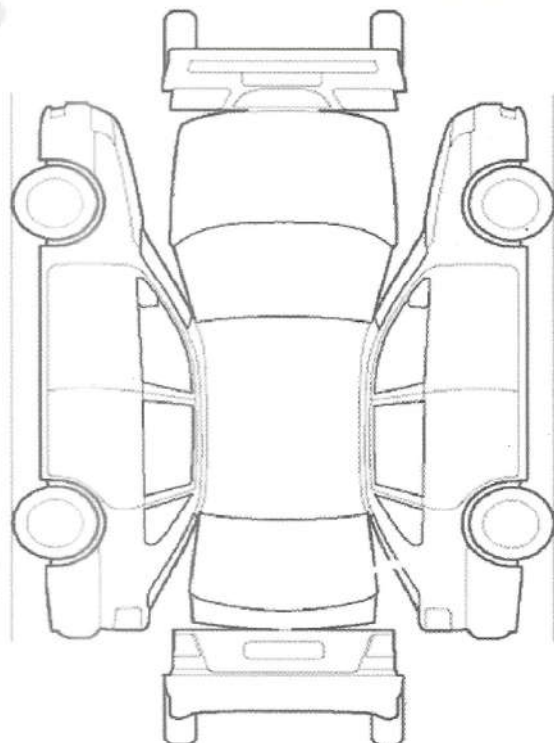

1. This vehicle is restricted to Singapore use only. 
