1. We act for **NEW GUAN HONG TRADING PTE LTD**, who is (our "**client**"), the Owner of motor vehicle no. YN 7916 S
2. We are instructed by our client to claim damages against you/your insured in connection with a road traffic accident along **JURONG WEST AVENUE 1** involving our client's vehicle registration number **YN 7916 S** and vehicle registration number **SHD 9989 Y** driven by your insured/you at the material time.
3. We are instructed that the accident was caused by your insured's/your negligence in the driving and/or management of your insured's/your vehicle. As a result of the accident, our client's vehicle was damaged and our client has been put to loss and expense, particulars of which are as follows:-

6. Please also note that if you are insured and you wish to claim under your insurance policy, you should immediately pass this letter and all the enclosed documents to your insurer.

Please note that you or your insurer should send to us an acknowledgement of receipt of this letter to us within 14 days of your receipt of this letter, failing which our client will have no alternative but to commence proceedings against you without further notice to you or your insurer. Our client's claim herein is quantified based on supporting documents in our file. Until a settlement is reached, all negotiations are conducted on the basis that the damages quantified herein are subject to revision if so instructed by our client.

8. Please also note that if you have a counterclaim against our client arising out of the accident, you are also required to send to us a letter giving full particulars of the counterclaim together with all relevant supporting documents within 8 weeks of your receipt of this letter.

9. Please note that this letter of demand is made without prejudice to our client's right to claim for personal injury damages arising out of the same accident.
