As the traffic clear & safe, I made a right turn towards Tampines Street 21. As I was approaching intersection between Blk 204 carpark entrance which is right opposite side of Yumin Primary School, Suddenly in a split seconds a lorry Nissan Cabstar (GR9275L) coming from opposite traffic which is in the side of Yumin Primary School made an abrupt turn in towards Blk204 carpark.

Thus the front side of lorry (GR9275L) colided with my motorcycle (FL7080M) on my front , right side. I had a few scrathes, cuts and bruises on my body. When ask, the driver told me that he did not see me coming.
