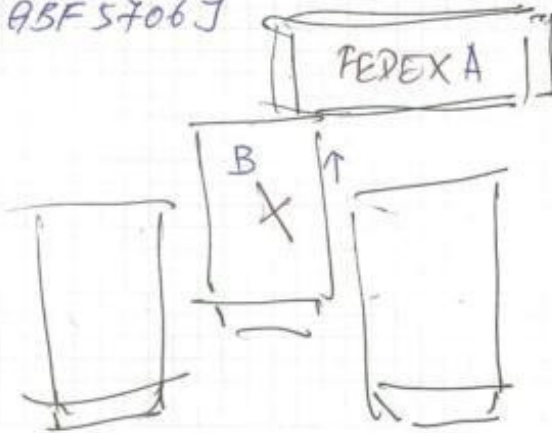
Sketch Plan #2

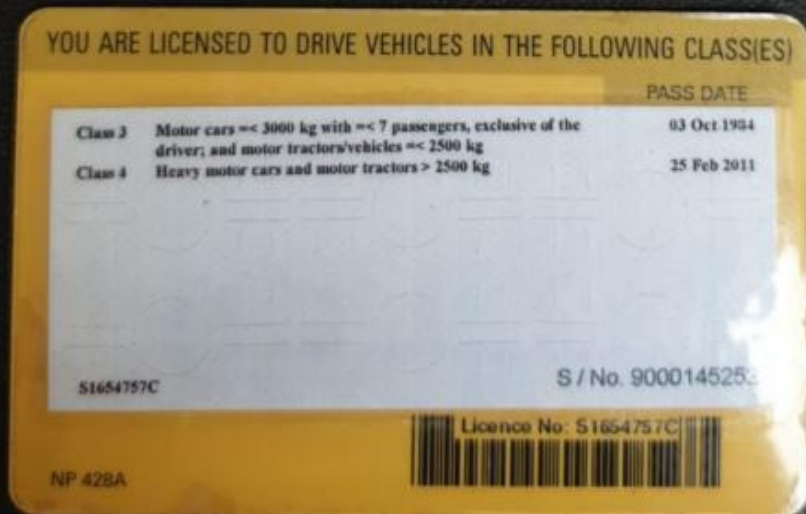
