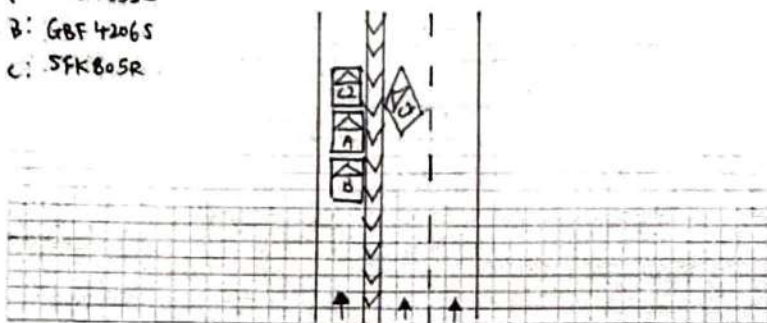

 Vehicle C: SFK805R




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

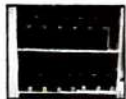
