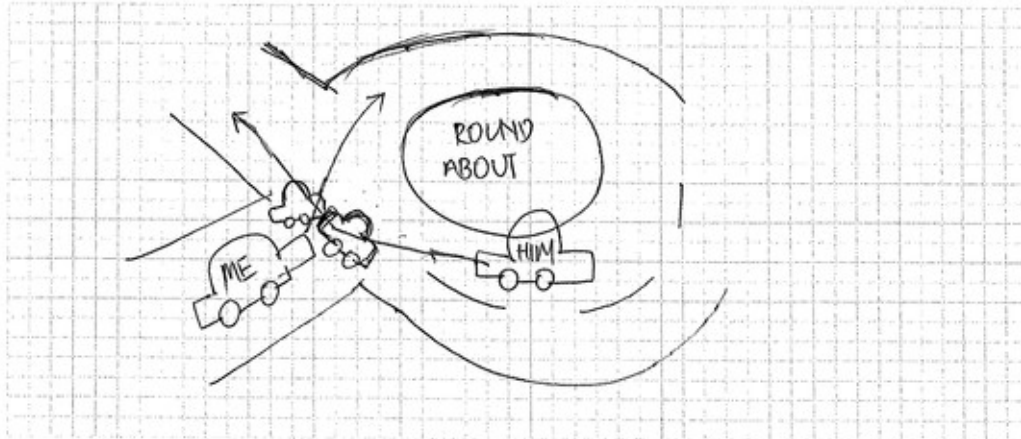

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving from the road at the bottom left, going into the round-about @ Serangan garden area. However, the driver was at the inner circle of round about and I did not expect him to make a fast turn to the outer side of round about to enter to the side road.
He was seen to be turning around the roundabout initially.
It all happened fast without any signalling or warning, hence I did not managed to stop in time, which resulted in the accident. However, when I noticed him switching lane to exit to the road when he is already near the exit of roundabout I am not able to turn left to dodge as there are cars driving beside me too. It will result in more severe accident if I attempt to dodge his car. Moreover, there are cars driving closely behind me, it will result in more collision.
Thus, I can only try to stop my car, but result in minor scratches to the opposite car, though my car has dents.
I have made police report the very next day after work. However it was my first time experiencing an accident, I did not know that I need to head down to insurance
