I noted that my rear car bumper had some minor abrasions. I took a quick glance and genuinely did not notice that there were any abrasion on the car behind me at that point in time. This was the first time that I had encountered such incident in all my years of driving. I was indeed careless and not observant enough to even realise that I had caused damage to another car.

On the incident day, I was rushing for a volunteer event at my temple as I was late for the event. My mind was in a turmoil due to heavy volunteer duties that I was assigned to. It was a genuine lapse of concentration on my part. I did not know it until I got this notice(TP/IP/22789/2020) from Traffic Police.

I understand that I broke the regulation and I sincerely apologize for my action. If given the opportunity, I am willingly to bear the expenses incurred by the other party and would like to apologize personally to the affected driver too.

This is certainly a hard lesson learnt. I will not repeat what had happened and will do my utmost best to provide any additional information required.

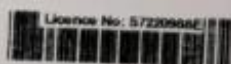
