

Brief Details.

On 30th December 2019 at around 6:40pm I was travelling along the Central Expressway towards the City on my bike FBN6293J. At that time I was in the second lane near the first lane, ahead of me there was a black Mercedes in the first lane. I checked my blind spot as I wanted to move to the center of my lane. When I looked forward the black Mercedes was halfway changing lane from the first lane to the second and it had braked in the middle of the first and second lane right in front of me and my bike. I tried to brake but I was unable to stop my bike in time and my bike collided into center rear of the black Mercedes I was thrown onto the road and rolled across the road due to the impact. When I came to a stop I was lying face up. I tried to stand up 3 times but I was unable to stand. The passenger of the black Mercedes and the driver came over to stand near me, they asked me why was I speeding to which I replied that I was going 80 on the expressway. I then asked them why they did not check their blind spot or signal to which they replied by saying that I was the one who had banged the back of their vehicle. At this point in time an Indian rider came to assist me in standing up as I was unable to. The driver and passenger of the black Mercedes then called for an ambulance. I was subsequently conveyed to Tan Tock Hospital where I was given 3 days MC for the period of 30th December 2019 - 1st January 2020. Traffic Police was at scene. There was no damage to government property. I do not have any helmet camera and I do not know the particulars of the other party or their vehicle as I was in a lot of pain and unable to exchange particulars with them. I only got a quick glance at the black Mercedes and I saw it's rear bumper had a palm size dent to it. My bike's front fork and the wheel was bent inwards. My front coversets, headlights and my side view mirrors were also smashed I'm not sure of any other damage as I only saw a picture of my bike after the accident and it was not a complete photo.
