Circumstances of Accident

I was turning into a parking space in front of the hawker centre on Circuit Road. My indicator was on. My passenger in the front seat said stop! But then a car drove into me. His right front hit my left side just in front of my front left tire. I was in front of him turning in with indicator and he drove into me. 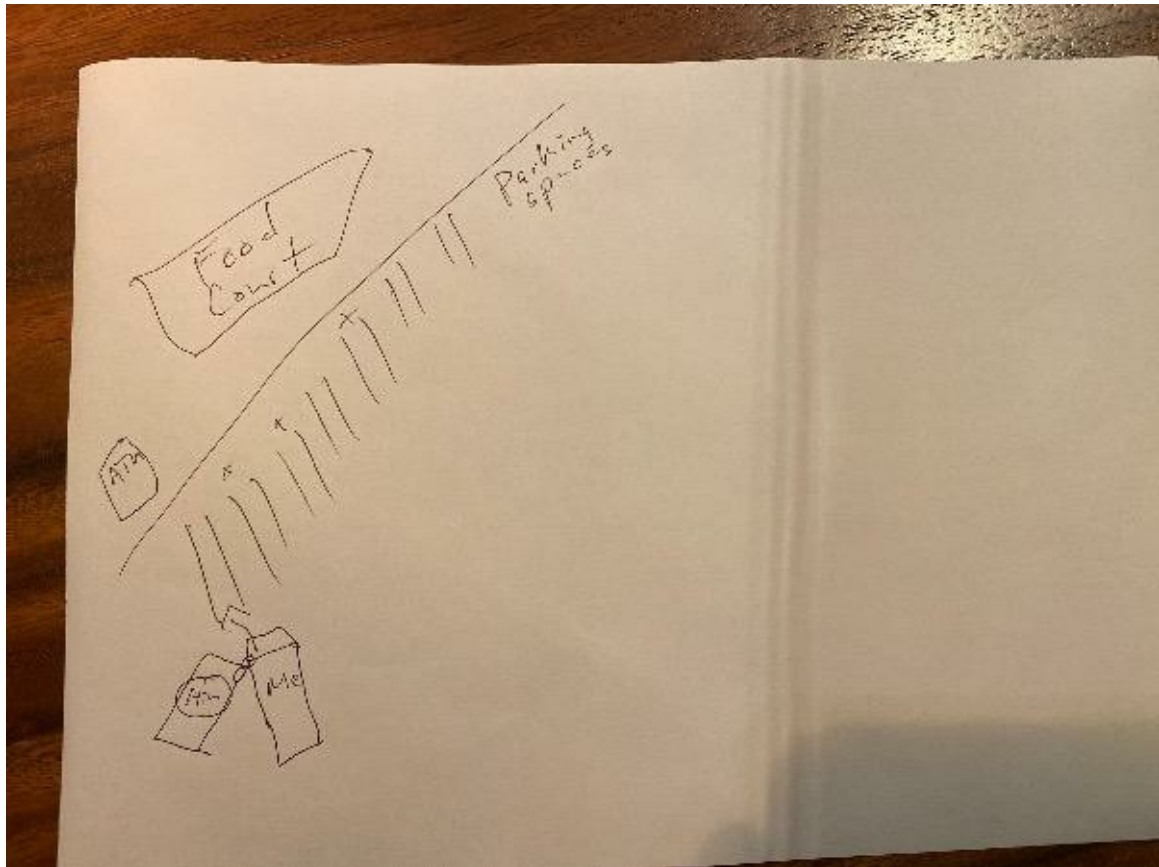

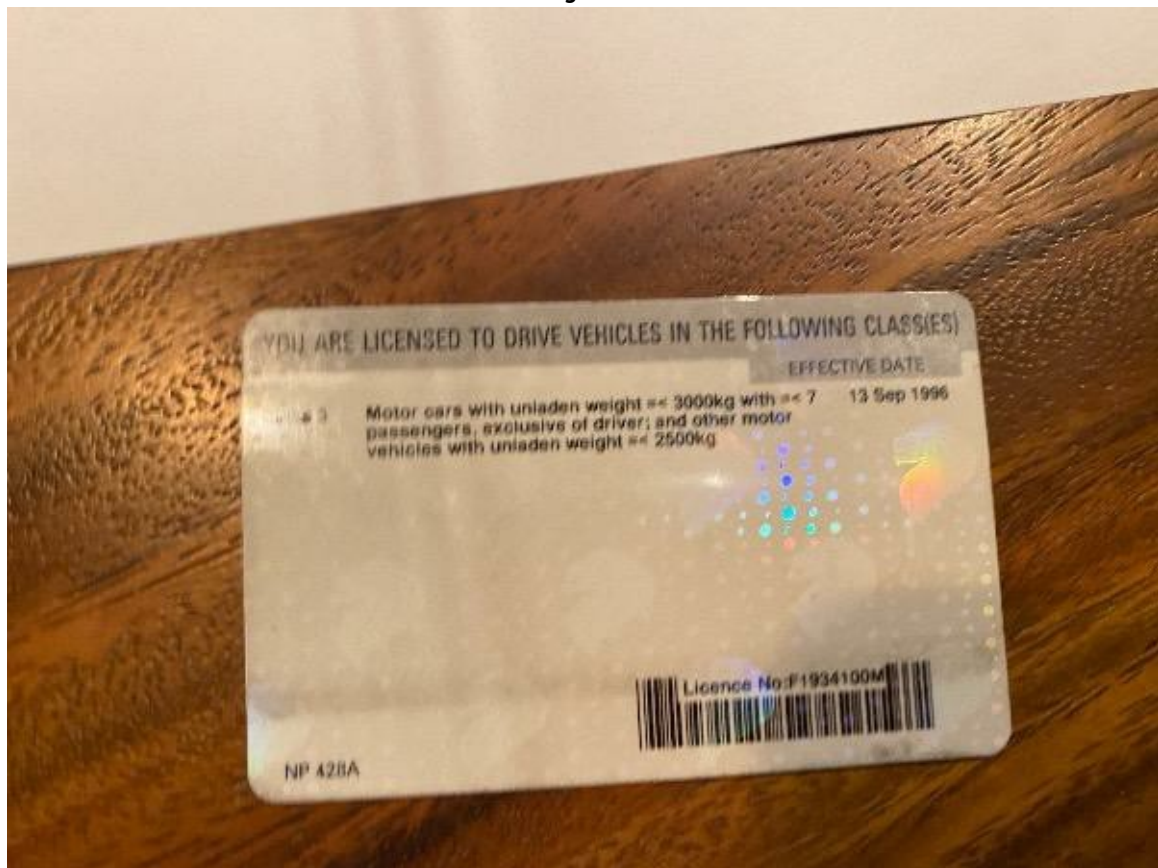
