CONTINUATION OF REPORT

Brief Details.

On 25/07/2020 at about 0930hrs I was driving my vehicle bearing the plate number SGU9368L along Dunman Road heading towards Old Airport Road. Suddenly a vehicle in front of me bearing the plate number ED9X stopped in the middle of the road without any prior signal. I could not react in time and collided with the vehicle in front of me.
