

## LETTER OF AUTHORISATION

1. The owner of motor vehicle no. GBB4579L hereby authorise **Ryder Auto Pte Ltd** to commence repairs of the said vehicle forthwith. 2. If the 3<sup>rd</sup> party claim is unsuccessful or partly successful as the case may be, I/we hereby instruct and authorise **Ryder Auto Pte Ltd** to claim direct from my/our insurance company on my/our vehicle immediately without any delay.
