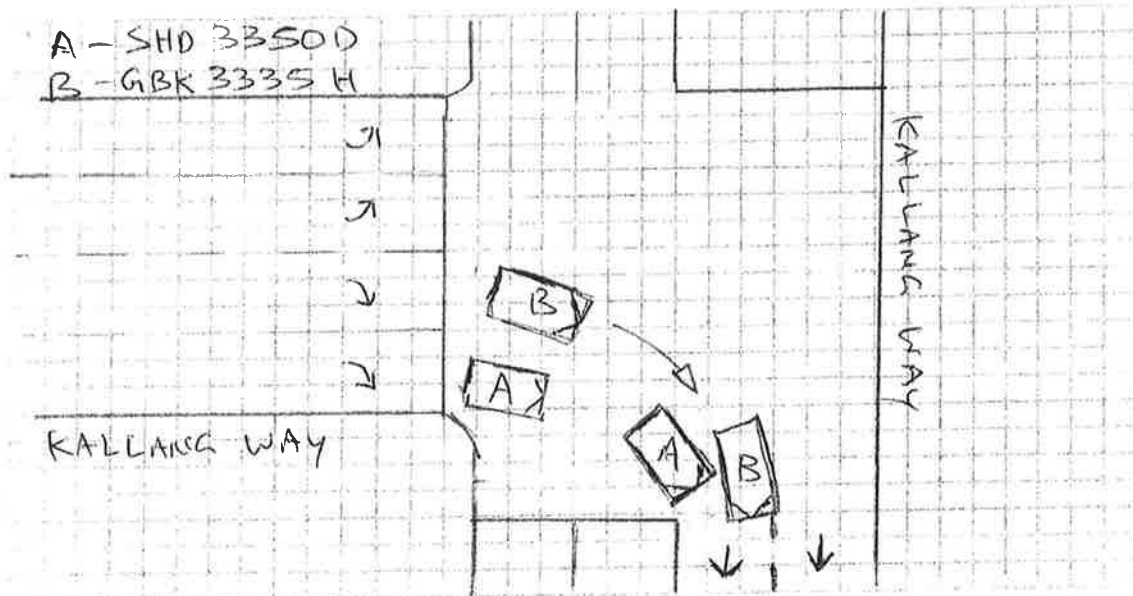

Describe Circumstances of the Accident.

On 27.07.2020, at about 1100hrs, I was driving my Comfort taxi, on the right lane along

Kallang way towards the T junction with Kallang Way.

While approaching the T junction, the lights were green in my favour. I continued

driving and was turning right into Kallang Way when a van, B, which was on the left lane

cut into my lane and its right rear side hit my taxi left front side.

I have a video recording of the accident showing B was on the left lane before the

T junction and cut into my lane while turning into Kallang Way and hit my taxi.

No pax in my taxi and no injury. Photos taken after the accident.

It was drizzling and light traffic.
