



| <p>It was a clear and fairly warm day.</p> <p>I was <del>exit</del> exiting from PIE towards Toh Guan Road. Upon entering Toh Guan Road and having checked my blindspot visually and using the side mirror as well, I made decision to change lane progressively to the outer most right lane. I was <del>at</del> 3/4 into the lane when an ambulance appeared <sup>out of nowhere</sup> and hit my car, on the right side. I did not see it, as it suddenly appeared. As my door was blocked by the ambulance, I had to move my car. Hence I <del>did</del> am not able to take picture of freeze point of the accident. After being able to get off my car, we took picture of my car and his. We exchange details quickly as he has to proceed to the hospital as there was patient. However the patient is fine.</p> <p>Also, the ambulance did not switch on the siren. Therefore I totally <del>am</del> not aware of his presence.
