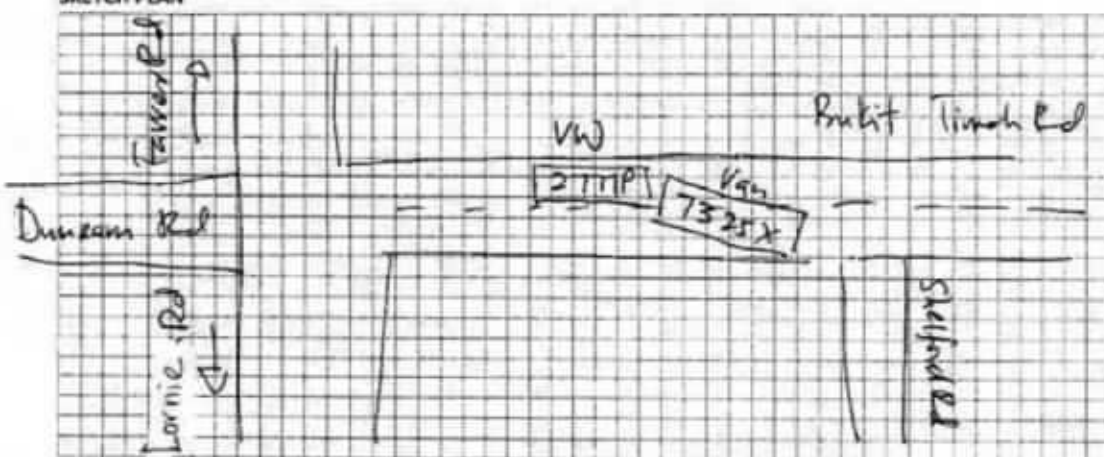

Subsequently after we parted ways, about 50 metres down the road, I saw he knocked into a NTUC Ceb as he tried to filter into Lornie Rd.


