Circumstances of Accident

THE ACCIDENT HAPPENED AT THE CAR PARK OF KK HOSPITAL ON THE MORNING OF 23 JUL 2020. MY CAR STOPPED TO PARK AT A SPOT AND I TRIED TO REVERSE TO PARK. DURING THIS PROCESS, THE CAR COLLIDED WITH THE CAR BEHIND AS HE WAS IN THE MIDDLE OF TWO LANES WRONGLY DUE TO WHICH I COULDN'T SEE HIM IN MY REAR VIEW MIRROR. MY CAR WAS IN THE RIGHT LANE. IT WAS A MINOR COLLISION WITH MINIMAL IMPACT ON BOTH CARS. THE COLLISION WAS PARTLY CAUSED BY THE MERCEDES DRIVER'S EAGERNESS TO OVERTAKE ME FROM THE RIGHT (MY RIGHT) WHICH MADE HIM GO ON THE WRONG LANE AND ALSO BLINDSIDED ME FROM THE REAR VIEW MIRROR.



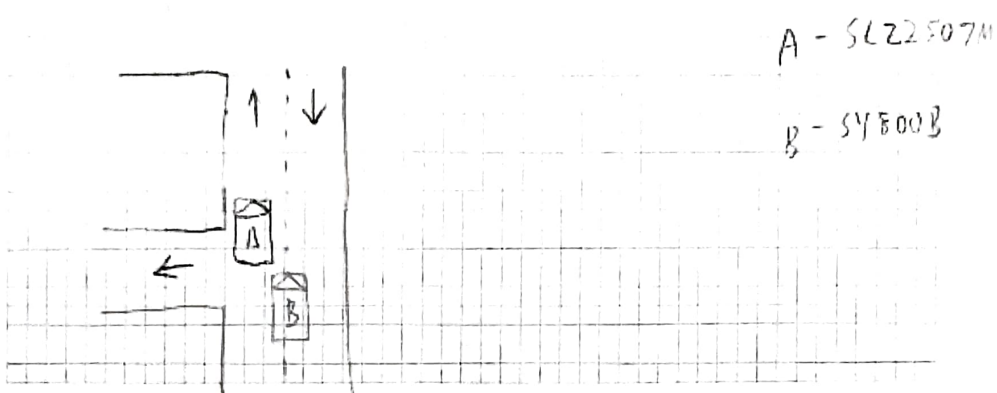

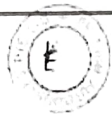
