
We refer to the above matter.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On the stated date & time, I, vehicle # was travelling in the

 left, of the stated venue. As I approach tuas road exit, vehicle  
 B came from lane 1 with the intention to exit. As the approach  
 was abrupt, vehicle B collided into my rear right hand,  
 causing my vehicle to lose control and struck the kerb  
 on the right, causing my tyre to burst and the  
 undercarriage to be damaged in the process

#### Circumstances of Accident

ON 28/07/2020 AT ABOUT 1820HRS, I HAD EXITED FROM PIE (TUAS EXIT) ON THE SECOND LANE OF THE ROUNDABOUT HEADING TOWARDS PIONEER ROAD. I SUDDENLY FELT AN IMPACT FROM THE REAR, VEHICLE B(GBD4145U) HAS CAME OUT FROM THE MINOR ROAD WITHOUT CHECKING FOR ON-COMING VEHICLES AND COLLIDED ONTO MY TAXI'S REAR LEFT PORTION.



Your client had reported that our insured had 'come out from the minor road without checking for on-coming vehicles and collided onto my taxi's rear left portion.

As there are no conclusive video footage to substantiate your client's claim that our insured vehicle exited from a minor road, we are of view that your client had fail to look out for oncoming vehicles while making the left turn to exit roundabout. Our insured driver should not be held liable.

In view of the above, we regret to inform you that we have our principal instruction to reject your client's claim based on BOLA 13(b).


We regret to inform that we do not have video or photo for this case.
