While I was traveling on the highway with my vehicle plate number SLP2348H the lorry with the plate number GBB6896H did a sudden stop in front of me and I did an emergency brake but somehow my vehicle hit the lorry in front of me which caused a serious damage to the front of my vehicle. After that hit managed to get of my car and took a look at the vehicle and I realized there were 2 more vehicle involved which were in front of GBB6896H. I managed to take down the other 3 vehicle owner's particulars as well.

I would like to state that nobody was injured expect for the driver of GBB6896H with a slight injury on his right hand at the scene and there was no ambulance at the scene.

I am lodging this report for the purpose of insurance claim and for my own record purposes. No government property was damaged and I did not suffer any injuries. That's all.
