On 11 June 2020, Thursday, at about 2.48 p.m., the motor trailer was travelling straight along PIE (Tuas) on lane 3 of a 6-lane road when the motorcycle collided into the rear portion of the motor trailer. Due to the accident, the rider of motorcycle landed on top of the trailer. The rider is currently unconscious and receiving treatment in hospital.

On 29 June 2020, Monday, at about 5.57 a.m., the motor taxi was in the midst of making a right turn from Upper Serangoon Road into Upper Serangoon Crescent and collided into the deceased's motorcycle that was travelling straight from the motor taxi's opposite direction. As a result of the accident, the deceased sustained multiple injuries and subsequently succumbed to his injuries in Changi General Hospital.
