May I seek your assistance to perform a detailed mechanical inspection of the <u>5 vehicles</u> below: [The ones marked in RED are deemed to be URGENT hence please EXPEDITE ON THESE REQUESTS]

- a) Case IAFP-IB-20200417 Mechanical Inspection of Motor Taxi, SHD658L (TP/IP/18129/2020)
- b) <u>Case IAFP-IB-20200417 Mechanical Inspection of Motorcycle, FBM8934T</u> (TP/IP/18129/2020)

On 4 April 2020 sometime before 1130 p.m., the accused was driving his motor taxi on lane 1 of 3-lanes along Bedok South Road and had made a u-turn at the opening in the centre median near to lamp post 39A when the deceased's motorcycle proceeded straight from the opposite direction and collided onto the left side of the accused's motor taxi. Deceased was conveyed to CGH where he succumbed to his injuries and was pronounced dead at CGH at 12.42am.

c) Case IAFP-IB-20200417 - Mechanical Inspection of Motor Car, SJN3125L (TP/IP/12357/2020)

On 4 March 2020 at about 9.58 pm, the driver of the motor car, SJN3125L, was driving along Bedok South Road when he claimed that he was making a 3-point turn by reversing into an empty parking lot and when he applied his brakes, the motor car started to accelerate and resulted in a spin before colliding onto a stationary motor car which was parked in a parking lot. The said driver then alleged there were mechanical fault to the motor car that he was driving.

d) Case IAFP-IB-20200417 - Mechanical Inspection of Motor Lorry, GBD8155P (TP/IP/05243/2020)

On 29 January 2020 at about 10.44 pm, the driver of the said motor lorry, GBD8155P, was driving along Marsiling Road when he claimed that he was negotiating a right turn at a junction and had applied brakes to slow down but the brakes were not working and the steering wheel was locked which resulted in the motor lorry to mount the road kerb and collide onto a barricade and a tree. The said driver then alleged there were mechanical fault to the motor lorry that he was driving.

e) Case IAFP-IB-20200417 - Mechanical Inspection of Motorcycle, FBK6836J (TP/IP/17661/2020)

On 1 April 2020 at about 6.11 pm, the rider of the said motorcycle, FBD6836J, was travelling in between lane 4 and 5 of a five lanes road along Paya Lebar Road when he collided into a pedestrian who appeared in front of him along the signalised pedestrian crossing from his right to left perspective. The rider applied brakes, swerved to the left and claimed that his handlebar hit onto the pedestrian. Due to the impact, the pedestrian who was reported to be unconscious, was conveyed to the hospital and currently under observation.
