Brief Details.

On 30/07/2020 at about 1705hrs, while I was driving vehicle bearing number SGY5360M (V3) along Bedok North Road together with my wife as a passenger. I noticed (V1, SJD9984L) come to a stop as giving way to a bus which exiting from bus stop no: 84459. Subsequently (V2, SKL6802U) also stop said vehicle.

As such I stopped my car which is about half car length behind V2. While V3 was stationary, about 2-5 seconds suddenly (V4, SLH2672M) came from the rear and hit onto my vehicle strongly. Due to said impact, V3 was forced forward and had hit onto V2 rear part of the vehicle.

As such we came out of our vehicle and spoke to all the involve parties. No visible injuries at scene as such no Police or Ambulance were called. Only Orange Insurance enforcement came down to assist and V3 was towed away. We exchange phone numbers and registration plate number. All came to an agreement to lodge report and make claim via V4 insurance.
