

**Brief Details.**

On 30.07.2020 at about 1430hrs, I was travelling along Boundary Road towards Upper Paya Lebar Road. I was at the Traffic light waiting to turn right to Upper Serangoon Road. I then alighted from my vehicle to check on the condition of my car and subsequently I saw the taxi driver started calling police.

There was damage to my vehicle, front bumper, right and left headlight damage, right and left bumper damage, crack/dent on left back bumper and front number plate were crack and dented.

Traffic police at scene and the officer had seized my SD card (in-car camera) for investigation. Ambulance was also at scene to check on the taxi driver and passenger as well.
