

- ② After that we moved out to the filter lane along Ang 460 Kia Ave 5 so as not to impede the traffic at Ang 460 Kia Ind. Pk 2.
- ③ I approach the driver and ask him why he jam on his brake when the road is clear.
- ④ He reply saying that a car is approaching. But in fact there is none.
- ⑤ He also says since I have hit his car, there is not need to report the incident.

- 1) At the junction of Ang 460 Kia Ave 5 and Ang 460 Kia Ind. Pk 2, our cars has stop at the filter lane (refer to Fig 1)
- ② As the traffic has stop from the right
- ③ Vehicle A starts to ~~move~~ filter out to Ang 460 Kia Ave 5
- ④ As I saw him moving off, I started to follow and at the same time looking out for vehicle on my right.
- ⑤ As the right vehicles has stop due to the traffic light is red
- ⑥ I turn my head towards the front vehicle. Suddenly vehicle A jam on the emergency brake. His vehicle has filter out about a quarter of his car length.
- ⑦ Upon seeing this, I immediately jam on my brake. But unfortunately, I have hit the vehicle in front.
