SKETCH PLAN



specialist cards telling me that they would take care of everything and tow my car away to their workshop, take myself and daughter to the doctor. I was so in shock and had no idea who these guys were and how they just appeared. Wilson did not have a camera phone on him as had just returned from camp as he is in the navy and they are not allowed camera phones. I took pictures of the cars for both of us, statement signed by both of us whilst these guys hung around waiting and kept trying to convince me to tow the car. My car was still mobile and functional with damage to the rear but drivable. My husband came from work to where we were and drove our car away. In hindsight I feel that it was no coincidence that these claim specialists were suddenly right at the scene and felt it my duty to report this to the police. This is not a police report for the actually car incident as Wilson and I are have exchanged details, made a statement, insurance informed. It is more that I feel that it may have been set up as feel very uneasy that the claim specialists appeared out of nowhere, it seems more than a coincidence.
