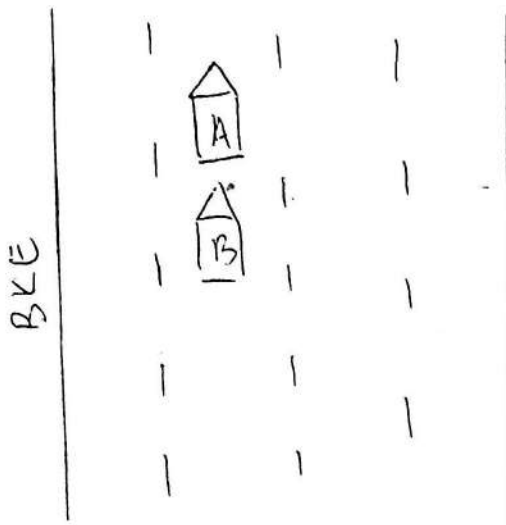

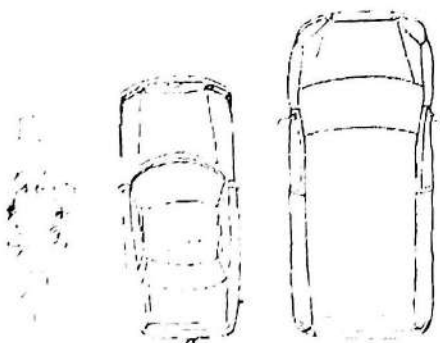

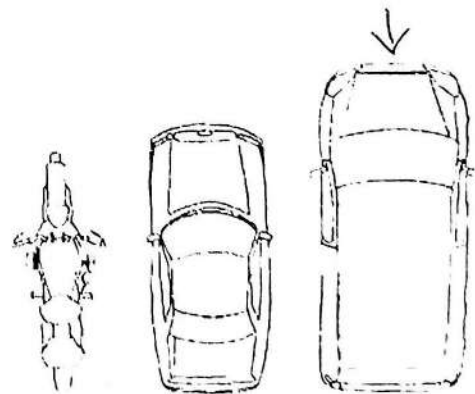


On 24/07/2020 at about 1726 hrs, I was driving along BLE towards SKE in my vehicle bearing the registration plate SKE 9660D in the third lane. It was drizzling and the road surface was wet. Due to the heavy traffic ahead of me, I slowed down my vehicle and almost came to a complete stop when I felt an impact from the rear of the vehicle. I wanted to stop at the side of the road to exchange particulars with the other driver. However the vehicle that hit my car (Honda Shuttle) sped off to my right side and continued along BLE towards northlands. Subsequently I reviewed my in-car camera footage and discovered that the license plate of the vehicle that collided into mine was SLX 9865T.
