Brief Details.

On the 06/08/2020 at about 0530hrs, I was awoken by my friend who asked me to go make a check on my bike, JSL6612, that was parked along Kempas road, at the back road towards a dead end.

When I went to make a check, I discovered that my bike had fell onto the floor and there were scratches on the left body, registration plate, left signal light, crack on the mudguard, damages to the gear and the front wheel of my bike can no longer turn.

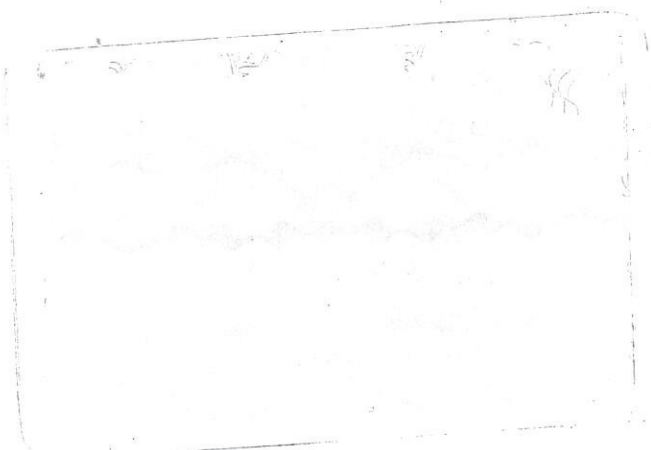
