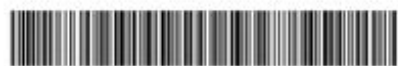

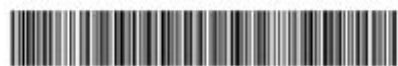

Brief Details.

On 6th August 2020 at about 2235hrs, i was travelling along East Coast Road making a left turn toward Telok Kurau Road. I was driving vehicle number SMH8695X. As i approached the pedestrian crossing, I stopped at the "Give Way lane" for an oncoming vehicle as he had the right of way. Suddenly, I felt an impact from the rear of my vehicle and I realised that i was rear ended by 3rd party vehicle bearing vehicle number SLJ8358X. We got down and exchanged particulars. My vehicle sustained major damage on the rear tailgate and bumper.

I had one passenger onboard at the time of the accident but she had confirmed with me at the point of time that she was not injured. My vehicle was not drivable and was towed to the workshop. I felt discomfort on my neck and lower back and went to seek medical consultation. I was given 3-Day MC from 07/08/2020 to 09/08/2020.
