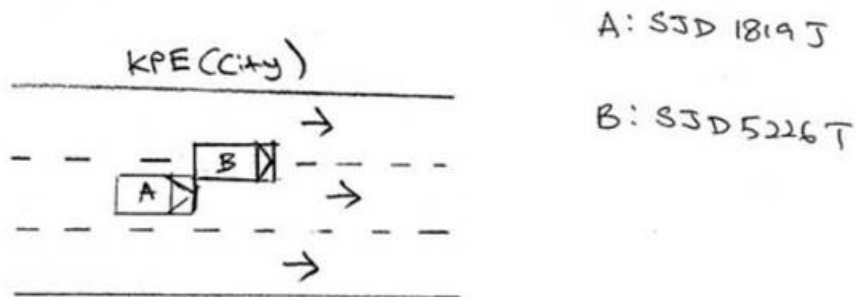
### WITHOUT PREJUDICE

#### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving vehicle A along KPE towards City
in lane 2. Vehicle B suddenly cut into my lane from
lane 3 and braked hard. Thus, the rear right of
vehicle B & the front left of my vehicle
collided.

We are of the view that liability is down against your client (SJD 5226T) for changing lane under BOLA 15.

In view of the above, we have instructions from our principal to deny the third party claim and we are unable to look into your client's claim.
