This is an older version of Prius and the price for the headlamp in your estimate is \$3,455.00. The 2 prices that you have provided in your email below does not correspond to the price as listed in your estimate.

I believe the price of **S\$2,637.60** for headlamp is correct for this model Prius. The computer sub-assy or commonly referred to as headlamp ECU comes separate from the headlamp ie it is not an assembly. For this taxi SHC 1323B, the headlamp ECU was not damaged. Hence, we have no alternative but to revise the price of the front headlamp to \$2637.60.
