CONTINUATION OF REPORT

Brief Details.

I am the driver of SMR1811X.

On 17/8/2020 at about 1030hrs, I was driving along TPE towards Changi directions. When I was reaching the Sengkang, Punggol area, I was travelling along Lane 4.

It was raining and all vehicles was moving slowly and I was moving at about 60km/h. I then noticed the vehicle ahead of me slowed down and I slowed down too. I then felt an impact from my rear and realised my car was hit by another vehicle.

I then stopped my car check with my wife, who was sitting at the front passenger seat. She said she felt pain at the tummy area and back. She was 3 months pregnant.

I then alighted from my car and realised it was hit by SJT5461X, which was then hit by SLR1107H. I briefly checked with the other drivers to make sure that there is no need for urgent medical attention or ambulance, and then proceeded to exchanged particulars with the other drivers, and took photo of the damages on the car. I also called 999 for advice, but was told that since there is no ambulance required, we may just leave the place. I drove off and proceeded straight to Mount Elizabeth (Novena) Hospital.

I was later given 7 days Outpatient MC, while my wife is being warded. I have an in-car camera that captured the accident
